PROPOSED ISSUANCE OF SUSTAINABILITY CONVENTIONAL MEDIUM TERM NOTES ("Sustainability CMTNs") PURSUANT TO RM60 BILLION MEDIUM TERM NOTES PROGRAMME ("MTN PROGRAMME")

This document ("**Pricing Supplement**") is issued to give details of an issue of Sustainability CMTNs by Cagamas Berhad (Registration No. 198601008739 (157931-A)) (the "**Issuer**") under the MTN Programme.

This Pricing Supplement is to be read in conjunction with the terms and conditions of the principal terms and conditions of the MTN Programme ("**Conditions**") made available on Bank Negara Malaysia's Fully Automated System for Issuing/Tending (FAST) (Facility Code: 201900073). Unless otherwise defined in this Pricing Supplement, capitalised terms used herein have the same meaning as in the Conditions.

This Pricing Supplement does not constitute, and may not be used for the purposes of, an offer or solicitation by anyone in any jurisdiction in which such offer or solicitation is not authorised or to any person to whom it is unlawful to make such offer or solicitation, and no action is being taken to permit an offering of the Sustainability CMTNs or the distribution of this Pricing Supplement in any jurisdiction where such action is required.

This Pricing Supplement and its contents are strictly confidential and are made strictly on the basis that the recipient shall ensure that they will remain confidential. Accordingly, this Pricing Supplement and its contents, and any information, which is made available in connection with any further enquiries, must be held in complete confidence.


PURPOSE OF PRICING SUPPLEMENT
