PROPOSED ISSUANCE OF ISLAMIC COMMERCIAL PAPERS ("SUKUK CAGAMAS") PURSUANT TO AN ISLAMIC COMMERCIAL PAPERS PROGRAMME ("ICP PROGRAMME") WHICH TOGETHER WITH A CONVENTIONAL COMMERCIAL PAPERS PROGRAMME ("CCP PROGRAMME") HAVE AN AGGREGATE COMBINED LIMIT OF RM20.0 BILLION IN NOMINAL VALUE

This document ("**Pricing Supplement**") is issued to give details of an issue of Sukuk Cagamas by Cagamas Berhad (Registration No. 198601008739 (157931-A)) (the "**Issuer**") under the ICP Programme.

This Pricing Supplement is to be read in conjunction with the terms and conditions of the principal terms and conditions of the ICP Programme ("**Conditions**") made available on Bank Negara Malaysia's Fully Automated System for Issuing/Tending (FAST) (Facility Code: 202300013). Unless otherwise defined in this Pricing Supplement, capitalised terms used herein have the same meaning as in the Conditions.

The establishment of the ICP Programme and the issuance of the Sukuk Cagamas under the ICP Programme have been duly authorised by resolutions of the Board of Directors' of the Issuer dated 25 March 2021, 13 July 2022 and 28 August 2022.

The Issuer hereby acknowledges that it has authorised Maybank Investment Bank Berhad (the "**Sole Lead Manager**") and their affiliates to circulate or distribute this Pricing Supplement on their behalf in respect of or in connection with the proposed offer or invitation to subscribe for and issue of the Sukuk Cagamas to prospective Investors who fall within the ambit of the selling restrictions as set out in the Conditions (with references to the various statutory provisions updated as may be necessary) ("**Selling Restrictions**") for the purpose of the sale of the Sukuk Cagamas described herein pursuant to the ICP Programme and that no further evidence of authorisation is required.

This Pricing Supplement does not constitute, and may not be used for the purposes of, an offer or solicitation by anyone in any jurisdiction in which such offer or solicitation is not authorised or to any person to whom it is unlawful to make such offer or solicitation, and no action is being taken to permit an offering of the Sukuk Cagamas or the distribution of this Pricing Supplement in any jurisdiction where such action is required.

This Pricing Supplement and its contents are strictly confidential and are made strictly on the basis that the recipient shall ensure that they will remain confidential. Accordingly, this Pricing Supplement and its contents, and any information, which is made available in connection with any further enquiries, must be held in complete confidence.

The Issuer is entitled to fully recover from the contravening party all costs, expenses and losses incurred and/or suffered, in this regard.
