PROPOSED ISSUANCE OF ISLAMIC MEDIUM TERM NOTES ("SUKUK CAGAMAS") PURSUANT TO AN ISLAMIC MEDIUM TERM NOTES PROGRAMME ("IMTN PROGRAMME") WHICH, TOGETHER WITH A CONVENTIONAL MEDIUM TERM NOTES PROGRAMME ESTABLISHED BY CAGAMAS BERHAD AT OR ABOUT THE SAME TIME AS THE IMTN PROGRAMME FOR THE ISSUE OF CONVENTIONAL MEDIUM TERM NOTES, SHALL HAVE AN AGGREGATE COMBINED LIMIT OF RM80.0 BILLION IN NOMINAL VALUE

This document ("Pricing Supplement") is issued to give details of an issue of Sukuk Cagamas by Cagamas Berhad (Registration No. 198601008739 (157931-A)) (the "Issuer") under the IMTN Programme.
